#### Eligibility Criteria

- > Candidates passed in Diploma examinations
- Professionals working in Registered Industry / Organization (Central / State) / Private / Public Limited Company / MSMEs located within 50 KM radial distance from the Institute.
- Minimum of ONE Year Full Time / Regular Working Experience
- > Qualification same as candidates eligible for Lateral Entry to Second Year
- All the Rules and Regulations of admissions are subject to change (if any) as per Government Policy / Order in Force.

#### Admission Guidelines

- Minimum Admission required to run the programme is 1/3 of the Approved Intake i.e., 10 candidates in each programme. In case less than 10 candidates have taken admission for a programme, that programme cannot be run and hence the admission of the candidate stands cancelled.
- Entrance Test (Multiple Choice (100 Questions) 2 Hrs duration) will be conducted on 18<sup>th</sup> August 2024 (i.e, Sunday) (for syllabus, etc., and for other updates refer https: <u>www.ouct.ac.in</u>).
- Reservations for SC/ST/BC categories are made according to the State Govt. rules in force at the time of admission.
- Duration of the Programme : 6 Semesters (3 Years)
  - Timings for conduct of classes shall be in the evening hours from 6:00 PM to 9:30 PM on all working days and on Sundays / Holidays at flexible and convenient timings of the Institution.

Tuition Fee : Rs. 70,000/ Per Annum + Other Fee as per the OU / College norms.
